In pursuance of the Director, FCS & CA Deptt., Assam vide order DS. 97/2013/76 dtd. 27/08/2013. The allocation of 2166.00 qtls of Whole Meal atta produced out of August 2013 regular quota of APL wheat is made to the following GPSS/F.P. Shops of Golaghat Sub-Division for lifting their respective allotted quota of allotment as shown against their names, subject to payment of required value as per rate fixed by the Govt.
