In pursuance of the Director, FCS & CA Deptt., Assam vide order DS. 97/2013/87 dtd. 17/09/2013. The allocation of 2336.00 qtls of Whole Meal atta produced out of **September 2013** regular quota of APL wheat is made to the following GPSS/F.P.
