ORDER

In pursuance of W.T. Message No. DS. 70/2013/22 dtd.23.12.2013 received from the Director, Food, Civil Supplies & Consumer Affairs Dept., Assam, Sub-allocation of 8496.64 Qtls. of BPL-Rice for the month of January/14 only is hereby made Revenue Circle wise to the following GPSS/F.P. Shops/ ATC Garden within Golaghat Sadar Sub-Division for lifting and distribution to the selected beneficiaries of their respective area of operation as per quantities of BPL-Rice shown against their names as follows. :-

The allottees concerned will have to lift their respective allotted quota of BPL-Rice from FCI, Jorhat after depositing required value of BPL-Rice within the validity period as fixed by the Govt. The last date of depositing value of BPL-Rice for the month of January/14 is up to 15th January /14. The last date of lifting is up to 20th January /14 for January/14 for for respectively as fixed by the Govt. The scale of issue is fixed @ 32.946 Kg. per BPL-FIC in respect of Urban Area and @ 26.397 Kg. per BPL-FIC in respect of Rural Area.
