**O R D E R**

In pursuance of W.T. Message No. DS. 142/2009/162 dtd. 02.05.2013 received from the Director, Food Civil Supplies & Consumer Affairs, Assam - 673MT (6730Qtls.) of Iodised Salt are hereby sub-allotted to the following GPSS/ F.P. Shops under Golaghat Sadar Sub-Division. The scale of Iodised Salt is fixed as @ 05 (Five) Kg. (approx) per Family for both rural & urban areas of Golaghat and Dergaon Town, under Golaghat Sadar Sub-Division.
