ORDER

In pursuance of W.T. Message No. DS. 3/2013/25 dtd. 18.04.2013 received from the Director, Food Civil Supplies & Consumer Affairs, Assam - 405MT(4050.00 Qtls.) of Levy Sugar (Regular) for the month of May/2013 is hereby sub-allocated to the following GPSS/F.P. Shops under Golaghat Sadar Sub-Division. The scale of levy sugar (Regular) is fixed as @ 624 grm. (approx) per head for both rural & urban areas of Golaghat and Dergaon Town, under Golaghat Sadar Sub-Division. The PDS Nominees/allottees should lift their respective allotted quota of Levy Sugar from FCI, Jorhat, after depositing of required value as fixed by the Govt. within 31.05.2013 as follows :-


