In pursuance of W.T. Message No.DS. 22/2012/96 dtd 29.09.2012 received from the Director, Food Civil Supplies & Consumer Affairs, Assam - 421MT(4210.00 Qtls.) of Levy Sugar (Regular) & 23MT (230.00 Qtls.) of Levy Sugar (Backlog) for the month of October/2012 is hereby sub-allocated to the following GPSS/ F.P. Shops under Golaghat Sadar Sub-Division. The scale of levy sugar (Regular) is fixed as @ 649grams (approx) & the scale of levy sugar (Backlog) is fixed as @ 35grams (approx) per head for both rural & urban areas of Golaghat and Dergaon Town, under Golaghat Sadar Sub-Division. The PDS Nominees/allottees should lift their respective allotted quota of Levy Sugar from FCI, Jorhat, after depositing of required value as fixed by the Govt. within 31.10.2012 as follows :-


