NOTICE INVITING TENDER



The interested firm/contractors must submit the tender to the undersigned within **29th February 2016** up to **2:00 P.M.** The tender will be opened on the same day at 3:00 P.M in presence of intending tenderers or their authorized representatives.

TERMS AND CONDITIONS

1. The sealed tender is to be addressed to the Deputy Commissioner & Chairman, DDMA, Golaghat and submit to the Office of the undersigned by 2:00 P.M on.. *29th February 2016.*
2. All the pages of the tender should be duly filled and signed.
3. Rates should be quoted on flat basis i.e. As per/Below/Above of plan and estimate uploaded in the district website or may be collected from the Disaster Management Branch, D.C's Office, Golaghat. (both in words and figure without any overwriting)
4. If the date of opening of the tender falls on any Govt. holidays, then the next working day will be treated as the date of receiving and opening of the tender.
5. Taxes shall be deducted as per provision of Income Tax and AGST. Act.
6. The tenderer shall have to submit the tender paper along with the following documents without which the tender shall be treated as incomplete and liable for rejection.
 - i. Attested copy of PAN Card/VAT registration certification/up to date VAT clearance certificate/G.I.R. No.
 - ii. In case of partnership firm or Limited company the firm must furnish attested copy the partnership deed and power of attorney. In case of Limited company the attested copy of registration certificate issued by the competent authority should be enclosed.
 - iii. The tenderer shall have to deposit 2% earnest money along with tender paper in the form of DD in favour of the undersigned.
7. Payment shall be made subject to the availability of fund.
8. The successful tender shall have to deposit 10% security money in the form of DD pledged in favour of the undersigned at the *time* of signing the agreement. They may also convert their 2% earnest money to security deposit if necessary, by applying to the authority.
9. The earnest money of unsuccessful tenders will be released to them after finalization of the tender.
10. Tenders accompanied by all required document be submitted under sealed cover. The name of the work along with the name & address of the tenderer should also be written on the envelope.
11. The undersigned shall not entertain any claim for price escalation during the period of execution of works.
12. The undersigned reserves the right to accept or reject any tender without assigning any reason thereof.
13. Contractors having satisfactory past performance may be given preference.
14. Tender will be valid for 6(six) months.
