Sir,

With reference to above and as reported by the Circle Officer, Dergaon Revenue Circle it may be mentioned here that the former land of Shri Shri Shiva DouL was eroded by river Gelabil and there is not record available in the Circle Office regarding the eroded land. Presently, land measuring 10 Bigha 04 Katha covered by Dag No.67 and 01 Katha 07 Lessa covered by Dag No. 69 of P.P. No.67 (total Land 11 Bigha 07 Lessa) of 1 No. Negheriting Grant Gaon of Dergaon Mouza stands mutated in the Name of Shri Shri Negheriting Shiva DouL. Presently, Shri Shri Negheriting Shiva DouL is situated at the said plot of land.

Land measuring 12 Bighas 02 Lessa covered by Dag No.71 of Tea Myadi Patta No.01 of 1 No. Negheriting Grant Gaon of Dergaon Mouza stand mutated in the name of the Historical Pond situated in front of the Shri Shri Shiva DouL. Although earlier the said land was in the name of Brahmaputra Tea Co., now it is Govt. land vide letter No. TLC.10/71-72/, dated 17-05-1976. The said land is now encroachment free.

In addition to the total 11 Bigha 07 Lessa of land standing in the name of Shri Shri Negheriting Shiva DouL, another 23 Bigha 04 Katha 12 Lessa of land standing in the name of Brahmaputra Tea Co. Ltd. is lying free in front of (in the North and South side) Shri Shri Negheriting Shiva DouL. After obtaining NOC from Negheriting Tea Estate, allotment proposal of the said land may be submitted from this end.


