

MINUTES OF THE EMERGENCY MEETING OF THE APPOINTMENT COMMITTEE HELD IN CONNECTION WITH SELECTION OF JUNIOR ASSISTANTS IN D.C'S AMALGAMATED ESTABLISHMENT ON 12TH MARCH, 2020 AT CONFERENCE HALL, D.C OFFICE, GOLAGHAT

An urgent meeting was chaired by DC Golaghat of appointment committee for selection of 23 Nos of Junior assistants in the Amalgamated Establishment of Deputy Commissioner, Golaghat. The members present in the meeting discussed about receipt, scrutiny and compilation of the database relating to the applications of the posts mentioned above. Already 1824 nos of eligible candidates were shortlisted for appearing in the written examination to be held on 15th March'2020 at various venues of the District Headquarter. This database was already shared in District Admin. Website, Official FB page & in Notice Board, DC office. However an urgency occurred due to receipt of several queries over phone, at personnel Branch etc. regarding requesting for reverification of their applications who did not get their Admit Cards/got rejected. As the entire process of recruitment needs to be completed by 31st March'2020 and the sanction for these parts were received recently from Govt. the process of scrutiny of received applications had to be completed within a short span. Additional Deputy Commissioner (P) appraised the house about all these aspects and the subsequent action plan for completion of the entire process within stipulated time. The issue of reverification was discussed in detail and Deputy Commissioner and the house took a considerate view on this so that no eligible candidate is deprived from appearing in the exam and allowed reverification. As directed the scrutiny committee performed this task with utmost sincerity and it was found that total 8 nos (eight) of candidates are eligible in addition to 1824 Nos and hence the total nos of eligible candidates becomes 1832. This was recommended by the house and it was decided to publish the revised database at Notice Board, D.C's office, Golaghat. But due to technical snag this could not be updated in the existing database. As advised by the vendor, serial Roll numbers was decided to allot to the additional 8 nos of candidates. Due to these factors, the revised database of 1832 eligible candidates will not be uploaded in the district website and FB page. However, copies of the same will be available at personnel branch for all necessary purpose.

Deputy Commissioner appealed to all members present for urgent, sincere and united action for completion of the entire process of recruitment in time with honesty and transparency.


The meeting ended with a vote of thanks from the chair.
